Rachel, Jess, Gabe, Frank, Jason N. and Betsy, There is a requirement to identify an investigative team for potential call out this Sunday. The need is dependent upon the level of criminal activity targeting Federal Officers/Agents and property in downtown Portland on Saturday night.

For example, last Saturday FPS arrested an individual for shining a laser into the face and eyes of several FPS Officers resulting in a Misdemeanor AFO charge. During the search incident to arrest, officers determined the subject was carrying a machete, a large mortar firework and a section of galvanized pipe with endcaps and fuze assembly. The subject was also carrying a phone for which he gave consent to search. The materials on his person met the elements of a destructive device charge, which led to a search warrant on his residence and a criminal complaint being executed by the DT Squad on Sunday.

The DT squad and VC Squad have been running hard for several weeks and we are trying hard to give them the weekend off. CTD is sending Fly Team Agents to cover the interviews of individuals arrested during the night and early-morning hours this weekend. They will also conduct initial exploitation of phones, or other communication devices they are carrying. These Agents may uncover a situation like the one described in the previous paragraph, which will require us to have Agents prepared for immediate investigative follow up if needed.

Following is a proposed list of Agents whom we are asking you to contact and check their availability for work on Sunday. The likelihood of this group getting tasked is low, but we want to send them a warning order in advance so we don't have to scramble on Sunday morning and disrupt their weekend with no notice. The plan would be to have 4 Agents for early morning response, writing affidavits and planning (Investigative Response Team), and another group on call (Search Team Roster) to fill out a search team if necessary.
