Jennings, Executive Vice President and Treasurer of Petitioner on the 27th day of October 2020, together with the Consent of the Board of Trustees and Officers of Petitioner, a Letter of No Objection, dated August 6, 2020, to the sale of the Premises from the New York State Department of Education pursuant to Section 216-a 4 d (3) of the New York State Education Law and an Endorsement of No Objection to the sale of the Premises from the Office of the New York State Attorney General, Charities Bureau pursuant to Sections 510 and 511 of the New York State Not for Profit Corporation Law, it appears to the satisfaction of the Court that the interests of the Petitioner will be promoted by selling the Premises, as defined in **Schedule A** made a part hereof, in accordance with the Contract Of Sale dated as of June 18, 2020 with Khal Torath Chaim Inc. ("KTC") ("Contract of Sale"). KTC assigned all of its right, title and interest in and to the Contract of Sale to Yeshivath Viznitz DKhal Torath Chaim Inc., ("YVDTC") by Assignment dated July 9, 2020 ("Assignment"). YVDTC is hereinafter referred to as "Purchaser". The Contract of Sale and Assignment are hereinafter referred to as "Contract" for a purchase price of Forty Five Million Five Hundred Thousand and 00/100 Dollars (\$45,500,000.00).

As of the date of the Contract, the Premises are encumbered by the 100 Mile Fund Loan with a principal balance owed of approximately Thirty Eight Million Five Hundred Thousand and 00/100 Dollars (\$38,500,000.00).

ORDERED, that NYACK COLLEGE be and it is hereby authorized:

To sell the Premises, as defined in Schedule A made a part hereof, in accordance with the Contract to Purchaser, for a purchase price of Forty Five Million Five Hundred Thousand and 00/100 Dollars (\$45,500,000.00).

Use the proceeds from the sale of the Premises as follows: approximately Thirty Eight Million Five Hundred Thousand and 00/100 Dollars (\$38,500,000.00) to pay off the 100 Mile Fund Loan, approximately Two Million Five Hundred Thousand and 00/100 Dollars (\$2,500,000.00) for closing costs, including without limitation, broker's fees of One Million Two Hundred and Fifty One Thousand Two Hundred and Fifty and 00/100 Dollars (\$1,251,250.00) per the Broker Agreement and interest and fees related to extending the 100 Mile Fund Loan for 60 days, and approximately Four Million Five Hundred Thousand and 00/100 Dollars (\$4,500,000.00) to complete the consolidation of Petitioner to the NYC Campus.
